Race Officer Duties

All registered skippers must be available to serve on Protest Committees when called upon, and must complete a minimum of two Race Committee duties during the racing year. Skippers registering for Winter or Summer only must complete one Race Committee duty. A Race Committee administration fee of \$50 per missed date will be charged to RVYC members who fail to complete the required duties. See the Race Committee sign-up board for available dates.

NOTE: The Race Committee Officer of the Day is responsible to ensure that he/she has enough personnel to assist him/her with the running of the races and will receive all protests. If you miss a race because of your Race Officer duties you will be awarded an average of your scores for that series. Please advise Race Committee Coordinator.

Race Committee Duties for Non-Members Only:

Because of insurance restrictions on the use of RVYC Club boats, non-members must sign up to assist a RVYC Race Officer. Non-members please sign up accordingly with a skipper of your choice.
